Sir/Madam,

As you may be aware that M/o. Minority Affairs, GOI has launched following two scholarship schemes for the year 2018-19 on National Scholarship Portal (NSP 2.0).

1. Post Matric Scholarships Scheme for Minorities.
2. Merit Cum Means Scholarship for Professional and Technical Courses.

The timeline activities for implementation of above said schemes are as under:

1. The last date for submission of online applications by the applicant – 30/09/2018
2. The last date for verification by the institutes - 15/10/2018.

In this regard, it is requested to ensure that your University/Institution/College should have login details for the purpose of verification of application received online by the students. However, in case your University/Institution/College don't have login details, you may immediately contact this directorate through email at [dhemoma@gmail.com](mailto:dhemoma@gmail.com).

Further, all Universities/Institutes/Colleges are requested to send the details of the Nodal Officer employed for monitoring & verification of applicants of scholarship schemes on National Scholarship Portal (NSP) for the year 2018-19 in the attached format (Annexure-I) duly signed by the Head of the Institution.

In the above said reference, it is also informed that as per the details furnished by the Nodal Deptt. i.e. Deptt. for the Welfare of SC/ST/OBC/Min, GNCTD, the applying process of the applications under the aforementioned schemes is very slow and very less number of applications received on NSP portal till date. Therefore, you are also requested to make the students aware of the said schemes by giving wider publicity so that maximum students may apply the said schemes before last date.
